INTERFAITH OUTREACH SUPPORTS INDIVIDUALS AND FAMILIES EXPERIENCING FINANCIAL CRISES, EMPOWERING THEM TO MOVE BEYOND POVERTY. IN FY21, 2,134 FAMILIES WORKED WITH US TO RESOLVE THEIR IMMEDIATE CRISES, MEET BASIC NEEDS, AND STABILIZE. 39% OF THESE FAMILIES MOVED FORWARD WITH FEWER EMERGENCY NEEDS, NAVIGATED BARRIERS MORE SUCCESSFULLY, AND ESTABLISHED PERSONAL PLANS TO ACHIEVE SHORT- AND LONG-TERM GOALS.
